**APPROVAL OF MINUTES – APRIL 2, 2001**

**UPON MOTION** by Commissioner Anderson, the Board voted unanimously to approve the April 2, 2001 minutes as presented.

**BIDS FOR DUMP TRUCK**

Jack Chandler stated that the Department of Public Works, with the help of Mr. Leon Harmon, advertised for bids on a new 12 cubic yard dump truck. The bids were to be received by and opened at 2:00 PM on Thursday, April 5, 2001, which they were.

Mr. Chandler stated that they only received one bid from Volvo/GMC Truck Center of Carolina. The bid price was \$76,500.00 for the truck plus \$1000.00 in sales tax for a total price of \$77,500.00. He recommended that the bid be accepted.

There was discussion about having this re-bid and having it ready for the meeting in June.

**UPON MOTION** by Commissioner Craig, the Board voted unanimously to rebid the truck in a timely fashion to hopefully have more bids.

**UPDATE FROM COUNTY ATTORNEY CONCERNING GOVERNORS ISLAND**

Jeff Taylor, County Attorney, stated that he spoke with Ed Perdue this morning. He stated that they discussed the district's options, which include condemning the system or purchasing the system. Condemning would be the most expensive option. Heater is willing to transfer the system to the County for \$48,000. This price is contingent upon Heater being able to abandon the existing plant, they would go through the steps that would be necessary to shut it down, but would not dismantle or remove it. Mr. Taylor stated that the figure may be negotiable.

Chairman Cochrane deferred a decision on this to let staff see what could be worked out on this.
