There was an additional request for waived fees of the Citizens Center from Maurice Moore to hold a fashion show to benefit the flood victims.

After a discussion by the Board, it was decided that the application should be under the name of a bona fide non-profit organization that would be willing to sponsor this event.

North Carolina Natural Heritage Inventory: Mr. Craig Wyant gave a presentation on the Natural Heritage Inventory, stating that fifty-three counties have completed the inventories. He requested that the Board defer action on this program until a recommendation is made by the Planning Board.

Public Comments: Chairman Hallman advised that this was the time the Board of Commissioners would receive comments from the citizens regarding any matter they desired to address.

Carol Clise presented information concerning the Governor's Island Sewer System.

Being no additional speakers, Chairman Hallman declared the Public Comments section closed.

Presentation of the Schedule of Values for the Appraisal Year 2000: Madge Huffman, Tax Administrator, presented the Schedule of Values for the Reappraisal for the year 2000. She requested that the Board set a Public Hearing for November 1, 1999 on the Schedule of Values.

UPON MOTION by Commissioner Saine, the Board voted unanimously to set a Public Hearing for the Schedule of Values on November 1, 1999 at 7:30 PM.

Mountain Island Lake Initiative: Erma Deen Hoyle stated that at the September 23, 1999 meeting of the Mt. Island Lake Advisory Committee, the Trust for Public Land recognized three local governments for their preservation efforts. Lincoln and Gaston Counties and the City of Gastonia were each thanked for their actions during the past two years to preserve significant portions of the western shoreline of Mt. Island Lake.

Parks and Recreation Facility Study: Erma Deen Hoyle introduced Robbie Brax of M. B. Kahn Construction.

Robbie Brax of M. B. Kahn Construction presented the Parks and Recreation Facility Study, stating that this is a ten-year plan. The estimated total cost for this plan is approximately 7.7 million dollars.

Commissioner Brotherton stated that about a year ago he and Commissioner Saine presented a plan for more fair distribution of the recreation dollars, and he still firmly stands by this proposal.

East Lincoln Community Center: Erma Deen Hoyle stated that she, Commissioner Brotherton, and Commissioner Waters met with four architects concerning the proposed Community Center at East Lincoln Park. Three of the four participated in a follow-up presentation regarding costs, fees, and development plans. Commissioner Brotherton and Commissioner Waters will present their recommendation for the selection of the architect for the project.

Commissioner Brotherton stated that three architects gave proposals and that two of them were in the \$900,000 range. Dan deBettencourt with dBf Architects took the original drawing and made some modifications to it. He did not reduce it in size, but made the outside more attractive. His cost estimate was \$623,700, which included his fees. He also presented them with a construction schedule, with a completion date of June, 2000. These figures \$623,000 do not include a sewer or septic tank. The sewer is within 1000 feet of this facility and Jack Chandler is coming up with cost estimates on extending sewer.

UPON MOTION by Commissioner Waters, the Board voted unanimously to proceed with the project and the numbers given, \$659,200 including the sewer costs.

Beattys Ford Access Area Lease Application: Erma Deen Hoyle presented the Board with copies of the Beattys Ford Access Lease Application. Ms. Hoyle stated that this application is due back to the Crescent office by December.

UPON MOTION by Commissioner Waters, the Board voted unanimously to authorize Erma Deen Hoyle to proceed with the application for the lease.

Changes in Lincoln County Work First Plan: Susan McCracken stated that they are making modifications to the Lincoln County Work First Plan to meet the new requirements of the State.

Set Public Hearing for Local Law Enforcement Block Grant for November 1, 1999 at 7:15 PM: **UPON MOTION** by Commissioner Brotherton, the Board voted unanimously to set a Public Hearing for Local Law Enforcement Block Grant for November 1, 1999 at 7:15 PM.

Alcohol Permit for Verdict Ridge Country Club: Chairman Hallman advised that this is not the County giving a permit, it is only appointing someone to address some information required by the State Alcoholic Beverage Control Commission.

Commissioner Brotherton stated that Mr. Knox applied for an ABC permit for his Country Club at Verdict Ridge. The ABC laws are written so he cannot qualify, but he must make application before he can take action. An official must be designated to make

a recommendation on the individuals character, zoning code standards, and fire standards. Throughout North Carolina normally the Sheriff of the county is the designated official. He stated that Sheriff Barbara Pickens has agreed to be the designated official.

Commissioner Waters stated that he feels the logical official to answer these questions would be the Chairman of the Board of Commissioners.

UPON MOTION by Commissioner Brotherton, the Board voted unanimously to designate Sheriff Barbara Pickens to make recommendations to the North Carolina Alcoholic Beverage Control Commission on ABC permit applications.

Y2K Update: Dante' Patterson, MIS Director, gave an update on Y2K. He stated that there are 22 personal computers that have issue of Y2K and of those 18 are from the Department of Social Services, which were budgeted for replacement. The components are in-house to be replaced effective starting Monday, October 25. One device in Elections has already been replaced and two other devices which are non-critical. Mr. Patterson stated that they are working on embedded chip issues such as fax machines, telephone systems, and other devices. Effective November 1, 1999 a Lincoln County Y2K address will be on our website to ease concerns.

Exotic Animal Ordinance: Chairman Hallman presented the proposed amendments to the Exotic Animal Ordinance under Section IV. Exceptions. (The amendments are shown in bold.)

IV. Exceptions

This article does not apply to:

- (1) veterinary clinics in possession of such creatures for treatment or rehabilitation purposes;
- (2) nonresident circuses or carnivals for no longer than one (10 twenty-day period, per each separate location where such circus or carnival is held within the county, per calendar year;
- (3) persons temporarily transporting such creatures through Lincoln County, provided that such transit time shall not be more than twenty-four (24) hours; or
- (4) owners or harbores of those species or breeds maintained or used exclusively for agricultural purposes.

(5) Owners or harborers of those species or breeds which are registered and comply with USDA regulations and are housed 2500 feet or more from a school, daycare, or public playground.

(6) Fowls of any type, domestic or exotic.

Commissioner Waters stated that he feels these animals should be registered with the Lincoln County Animal Control, because that is who is enforcing this. He stated that he feels it should read: **(5) Owners or harborers of those species or breeds which are registered with the Lincoln County Animal Control and comply with USDA regulations.**

Commissioner Waters stated that he feels that he feels B(1) under Definitions needs to be reworked also.

UPON MOTION by Commissioner Waters, the Board voted unanimously to defer the Exotic Animal Ordinance effective date until January 1, 2000 to rework.

UPON MOTION by Commissioner Saine, the Board voted unanimously to approve the appointments.

Calendar: Chairman Hallman presented the Board's calendar for November, 1999.

County Commissioners' Report: Chairman Hallman stated that he went to the Chamber Retreat at Lake Lure.

County Manager's Report: Stan Kiser, County Manager, reported that Dr. Skinner of Gaston College has informed him that they have applied for campus status at the Lincoln Center. Campus status would provide additional State funds.

Mr. Kiser also reported that healthcare costs for employees are going up 11.7% next year, and dental is going up 1.6%. He stated that they are meeting on October 22, 1999 with Linda Cline of the Risk Management Pool of the North Carolina Association of County Commissioners, hoping to achieve more favorable rates.

He stated that a previous Board established that merit checks would be given out during the holiday season every year. These merit checks will go out on November 24, 1999.

Other Business:

Resolution In Support of a Traffic Signal at East Lincoln Middle School: Chairman Hallman presented the following Resolution concerning a traffic light at East Lincoln Middle School.

**A RESOLUTION IN SUPPORT
OF
A TRAFFIC SIGNAL AT EAST LINCOLN MIDDLE SCHOOL (NC HWY 73)**

WHEREAS, East Lincoln Middle School is located on busy Highway 73; and

WHEREAS, traffic conditions are unsafe at various times each day.

WHEREAS, North Carolina Department of Transportation has added East Lincoln Middle School to its list of similar requests

WHEREAS, North Carolina Department of Transportation does not have sufficient funds to place a traffic signal at this time.

WHEREAS, North Carolina Department of Transportation has placed this request on a “waiting list” until funds can be obtained.

THEREFORE, BE IT RESOLVED, that the Lincoln County Board of Commissioners requests Legislative members representing Lincoln County secure funds to install a traffic signal as soon as possible.

BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded to Senate President Pro Tem Marc Basnight, the Lincoln County Legislative Delegation, and Board of Transportation member Jack Palmer, Jr.

UPON MOTION by Commissioner Waters, the Board voted unanimously to execute the Resolution In Support of a Traffic Signal at East Lincoln Middle School.

Highway 16: Commissioner Brotherton reported that last week the Gaston County Board of Commissioners were presented with a proposal from the NCDOT to purchase twenty acres of property in the Lucia area for an intersection for the new four-lane Highway 16. The offering price was somewhat more than the appraised price. The Gaston County Board of Commissioners voted 4 – 1 to reject the State’s offer. This will possibly delay the construction of four-lane Hwy. 16. He stated that he would like to see the Board send a letter to the North Carolina Department of Transportation urging them to proceed immediately with condemnation of that property to avoid any delays on the construction of the new Highway 16.

UPON MOTION by Commissioner Brotherton, the Board voted unanimously that a letter be written to North Carolina Department of Transportation and Legislative Delegation urging them to proceed immediately with condemnation of that property to avoid any delays on the construction of the new Highway 16.

Sailview: Commissioner Brotherton stated that Crescent Resources have not taken care of their obligations, including the stop light at Highway 16 and Webbs Chapel, a turn lane at the convenience site, plus additional turn lanes on Hwy. 16 and Webbs Chapel. Mr. Taylor sent them a letter ten days ago, asking them to respond with a date that they would have these improvements completed. At the last Board meeting, the Board discussed taking action to revoke their subdivision approval. He stated that he would like to see the Board take the action to begin the steps tonight to revoke the approval of their subdivision. If the subdivision approval is revoked, Crescent Resources should be made to come back before the Board for approval of Phases 2 and 3.

Jeff Taylor, County Attorney, said that he sent the letter to Crescent about two weeks ago asking for a completion date. He said that he has been out of town, and hasn't checked his voice mail from today, but as far as he knows, there has not been a response.

Chairman Hallman suggested having Jeff Taylor, County Attorney, write Crescent another letter telling them that the Board has instructed him to begin the process of revoking the subdivision approval.

Commissioner Brotherton stated that he thinks the Board needs to vote that they are beginning the process of revoking Crescent's subdivision approval subject to what Jeff Taylor finds out from the Institute of Government as to what the process is. If Crescent wants to solve this problem, while Mr. Taylor is conferring with the Institute, it is their option.

UPON MOTION by Commissioner Brotherton, the Board voted unanimously to begin the process of withdrawing the subdivision approval for Sailview, and instructed County Attorney Jeff Taylor to inquire to the proper state agencies what methods to follow in order to accomplish this.

Schools: Commissioner Brotherton stated that he has been working on a plan for the enlargement of East Lincoln High School to 1800 to 2000 student capacity. The School Board submitted a plan through Kahn costing \$21 million to do this. He stated that he believes it could be taken to that capacity for six to eight million dollars. He said that he had a very reputable architect on the premises a few weeks ago, and the architect was in agreement.

A floor plan was needed, and he found that there are not floor plans for any schools in Lincoln County. The School Administration and Fire Marshal's office do not have floor plans. Commissioner Brotherton stated that this is a safety issue.

Commissioner Brotherton stated that the architect would need a floor plan to review so he can bring the Board a proposal. The architect felt he could put a proposal together for enlarging East Lincoln High School for \$4,000 to \$5,000.

Chairman Hallman suggested having the Fire Marshal put together a floor plan for East Lincoln High School.

Reimbursing School System: Stan Kiser, County Manager, stated that the schools have submitted their water bills for July and August for reimbursement. The bill for July is \$4992 and the August bill is \$7883. Mr. Harmon has suggested that next year the Board include this in the budget.

UPON MOTION by Commissioner Waters, the Board voted 3 to 1 (Commissioner Saine against) to cover the reimbursement of water bills for the school system until June 30, 2000.

Construction Cost Estimate for Smithstone: Jeff Taylor, County Attorney, stated that the developer of Smithstone has requested that the Commissioners exercise their discretion under the Subdivision Ordinance to reduce their bond. The Board approved their bond of around \$800,000 to secure their installation of their infrastructure on the project. They have completed some of this, and want to reduce the bond as they go along. The original request was to reduce it by \$568,433.94, but Kelly Atkins informed him that staff has determined that figure is too high. Staff has given their approval of the figure \$444,943.94.

UPON MOTION by Chairman Hallman, the Board voted unanimously to reduce the bond for Smithstone by \$444,943.94.

Adjournment: **UPON MOTION** by Commissioner Waters, the Board voted unanimously to adjourn at 8:15 PM.
