Parallel Conditional Use Rezoning No. 37, Flay Clifton Scronce, applicant.

Judith Francis, Zoning Administrator presented Parallel Conditional use Rezoning No. 37, Flay Clifton Scronce, applicant. The applicants have requested to change application to R-S rather than a rezoning to R-R, which would only involve one (1) parcel, and not the original three (3). They won't need a Conditional Use permit in the R-R. The applicants are still interested in a Class A Mobile Home Subdivision.

The applicant is requesting to rezone approximately 105 acres along Wyant and Hoover Roads from R-SF to R-S. The property is located off of Wyant and Hoover Roads in Vale. It consists of three tracts, and all owned by the Scronce family. It is surrounded on all sides by R-SF zoning and lies entirely within the WS-IIP watershed. According to the GIS, there are currently two houses on these tracts. The Lincoln County Land Development calls for lower density residential developement in this area.
