Reclassify the Utility Technician Crew Leader job description from a pay grade 11 to pay grade 14 to maintain equality of this position in line with the Utility Crew Leader position.

Presentation from SSG Ronald Rhodes: Dale Punch thanked the Board for allowing waived fees for the deployment ceremony at the Citizens Center.

Staff Sergeant Ronald Rhodes thanked the Board for their support and said this county is by far the most patriotic in the state. He presented the Board with a plaque made by members of the NC National Guard in the shape of Lincoln County for their support before, during and after the unit's deployment in support of Operation Iraqi Freedom.

Presentation to Shane Campbell – Eagle Scout: The Board presented a Resolution to Shane Campbell, Eagle Scout.

Public Comments: Chairman Patton advised that this was the time the Board of Commissioners would receive comments from the citizens regarding any matter they desired to address.

Larry Turbyfill spoke concerning backflow preventers.

Gary Caldwell spoke concerning backflow preventers.

Terry Turbyfill spoke concerning the Agreement Concerning Water Supply by the City of Lincolnton and Lincoln County and backflow preventers.

Rudy Bauer said he feels the shot that damaged the fire boat came from the Burton Creek site.

Robert Avery spoke concerning the Schedule of Values and suggested that Madge and
Being no additional speakers, Chairman Patton declared the public comments section closed.

LINC ALERTS AND LINC INFO Presentation: Martha Lide gave a presentation on LINC Alerts and LINC Info, the county's new Reverse 911 system. Phone numbers are downloaded from the white pages. The LINC Alerts is for true emergencies and weather alerts. LINC Info. is a total opt-in system, where users have to update their profile to request these.

Coral Sanders gave a presentation on the LINC Alerts and LINC Info showing how to sign up for the service and also how alerts are sent out to citizens.

Road Naming Public Hearings – Netta Anderson: Netta Anderson presented the following information:

EDWARDS FARM LANE

This road is located off of Daniels Road, at the property owner's request to name the private road that accesses Daniels Road via this private road. The road name proposed is **Edwards Farm**

Lane and was agreed to by all residents. The name is not a duplicate or sound-alike and has been approved by the Addressing Department.

Chairman Patton opened the Public Hearing concerning Edwards Farm Lane. Being no speakers, Chairman Patton closed the Public Hearing.

UPON MOTION by Commissioner Robinson, the Board voted unanimously to approve the road name Edwards Farm Lane.

WYLIE ESTATES LANE

This road is located off of Vesuvius Furnace Road and requires naming due to the fact that there are now three structures that access Vesuvius Furnace Road via this private road. The name proposed is Wylie Estates Lane and was agreed to by all residents. The name is not a duplicate or sound-alike and has been approved by the Addressing Department.

Chairman Patton opened the Public Hearing concerning Wylie Estates Lane. Being no speakers, Chairman Patton closed the Public Hearing.

UPON MOTION by Commissioner Arena, the Board voted unanimously to approve the road name Wylie Estates Lane.

Airlie Park, Phase 2 Engineering Contract – Burns Whittaker: Mr. Whittaker presented the following information.

Phase 1 of the infra-structure improvements is well underway to support HYDAC. Construction bids for both the road and the utility work came in significantly under budget. LEDA has advised us that interest in the Airlie Park is strong and that completion of the Road to Rufus Road will improve the marketability of the Park even further.

In order to put the County in a position to move forward with Phase 2 Improvements in response to a potential new industry, we recommend that design work begin on the Road as well as the extension of the water line. Since the BOC award the original design work to McGill and Associates and they have performed the work satisfactorily, we request they be awarded the Phase 2 work as follows:

- a. Design and permitting of the water and sewer improvements for Phase 2 in the amount not to exceed \$23,000.
- b. Design and permitting of the Road extension for Phase 2 in the amount not to exceed \$108,200.

Additionally we request that the Board waive the requirements of the Mini-Brooks Act to allow direct award to McGill without further solicitation of proposals.

UPON MOTION by Commissioner Klein, the Board voted unanimously to waive the requirements of the Mini-Brooks Act.

UPON MOTION by Commissioner Arena, the Board voted unanimously to allow direct award to McGill without further solicitation of proposals as presented.

Appoint Voting Delegate for NCACC Annual Conference: **UPON MOTION** by Commissioner Arena, the Board voted unanimously to appoint Commissioner Jim Klein as the voting delegate for the NCACC Annual Conference.

License Agreement with Howards Creek VFD: George Wood presented the following information:

It is recommended that the Board approve the License Agreement with Howard's Creek for space to be occupied by the Sheriff's Office and Emergency Medical Services (EMS) in the new Howard's Creek Fire Station being constructed. It is necessary to approve the License Agreement at this time to provide documentation for Howard's Creek Fire Department to secure financing for construction of the facility.

In April 2010, Howard's Creek Fire Department Chief Dusty Rudisill, presented a plan to the County Commission for the construction of a new Howard's Creek Fire Station that will be located on Highway 27. The new station has been developed to incorporate space for the Sheriff's Office and EMS. The co-location of offices is seen as an efficient way of providing these public safety services.

The new station will have approximately 14,500 square feet. The License Agreement calls for the Sheriff's Office and EMS to occupy approximately 2,228 square feet of the facility. The proposed Agreement provides that the actual rental will be based upon the percent of square footage that EMS and the Sheriff's Offices occupy, times the cost per square foot of the building construction cost and financing as determined by the original construction contract award and all approved change orders during said construction, divided over the 25-year loan period. We estimate that cost to be between \$27,000 and \$31,000 annually. The term of this Agreement is 40 years, with the County paying the proportional share of the construction costs over 25 years, and then paying \$1 per year for the next 15 years.

The Agreement also calls for the County to pay a prorated share of the utilities (electricity & water) and buildings and grounds maintenance (grounds maintenance, pest management, trash removal etc) based on percentage of square feet occupied.

The actual rent amount and formula for dividing utilities and maintenance will be approved by the County Manager.

It should be noted that the actual street number of the new station has not been determined. Once it has been set, Chief Rudisill will provide us a letter that can be attached to this lease.

LICENSE AGREEMENT

Agreement made this ____ day of July 2011, by and between HOWARD'S CREEK VOLUNTEER FIRE DEPARTMENT, INC., a North Carolina nonprofit corporation, hereinafter referred to as Licensor, and LINCOLN COUNTY hereinafter referred to as Licensee, for use by EMERGENCY MEDICAL SERVICES, and the LINCOLN COUNTY SHERIFF'S OFFICE. In consideration of the mutual promises contained in this agreement, the parties agree as follows:

**SECTION ONE
GRANT OF LICENSE; DESCRIPTION OF PREMISES**

Licensor hereby grants to Licensee a license to occupy and use, subject to all of the terms and conditions of this agreement, a portion of its premises in its fire station to be located at on NC Hwy 27, Lincolnton, North Carolina (the "Property"), subject to the limitations and exclusions contained in this Agreement. Licensee may use said premises only in a fashion that does not interfere with Licensor's operation of its fire station on said premises.

SECTION TWO LIMITATION TO DESCRIBED PURPOSE; TERM

a. The above-described Property may be occupied and used by Licensee solely for a base of operations for an ambulance and/or Quick Response Vehicle crew and Sheriff's Office operations and for incidental purposes related to such purposes for and during the term contained hereunder.

b. It is the intent of this agreement to have joint occupancy for 40 years. This License shall commence upon the completion and obtaining of a certificate of occupancy upon the facility constructed upon the Property, and shall continue for a period of 40 years thereafter.

SECTION THREE PAYMENT FOR USE

Licensee shall pay Licensor for this license the sum of approximately \$27,000 - \$31,000 annually , or \$2,250 - \$2,583 per month, payable on or before the 10th day of each month for the first 25 years of the license and shall pay \$1.00 per year for the next 15 years. The actual rental shall be computed based upon the square footage that Licensee shall occupy, times the cost per square foot of the building construction cost and financing as determined by the original construction contract award and all approved change orders during said construction, divided over the 25 year loan period. The reason the rent is decreasing after twenty-five years is because the County will have paid its proportional share of the debt in years 1 through 25. Throughout the term of this Agreement, the Licensee shall also pay a prorated share of the utilities (electricity & water) and buildings and grounds maintenance (grounds maintenance, pest management, trash removal etc) based on percentage of square feet occupied on a monthly basis, said share not to exceed one-third (1/3) for any such bill.

SECTION FOUR INDEMNIFICATION

Licensee shall exercise its privileges under and pursuant to this Agreement at its own risk, and, irrespective of any negligence of Licensor. Licensee shall indemnify, defend, and hold Licensor harmless from and against any and all liability for damages, costs, losses, and expenses resulting from, arising out of, or in any way connected with, the occupation or use of the above-described property by Licensee, or licensees, invitees, or guests of Licensee, or the failure on the part of Licensee to perform fully all and singular Licensee's promises contained in this Agreement.

SECTION FIVE GOVERNING LAW

It is agreed that this agreement shall be governed by, construed, and enforced in accordance with the laws of the State of North Carolina.

**SECTION SIX
ENTIRE AGREEMENT**

This agreement shall constitute the entire agreement between the parties and any prior understanding or representation of any kind preceding the date of this agreement shall not be binding upon either party except to the extent incorporated in this agreement.

**SECTION SEVEN
MODIFICATION OF AGREEMENT**

Any modification of this agreement or additional obligation assumed by either party in connection with this agreement shall be binding only if evidenced in writing signed by each party or an authorized representative of each party.

**SECTION EIGHT

Motion to Approve an Agreement Concerning Water Supply by City of Lincolnton and County of Lincoln:

The County and the City of Lincolnton entered into an agreement on March 1, 2006 for the purchase and/or exchange of water, and have an interconnection between the two systems on Bethel Church Road. That agreement expired on June 30, 2011, and we are still in the process of discussing some alternatives to a long-term agreement.

At a recent meeting of the Mayor, Commission Chair, two manager, and the two public works directors, it was agreed to request that both the County Commission and the City Council extend the current agreement under the same terms and conditions for one year. That should give us time to work through these issues for a long-term agreement.

WHEREAS the parties entered into an agreement dated March 1, 2006 concerning water supply by and between the City of Lincolnton and the County of Lincoln to sell and/or exchange water into the respective systems; and

WHEREAS the agreement terminates June 30, 2011, and the parties desire to extend the agreement for one year from the date of the execution of this extension under the same terms and conditions as set forth in the March 1, 2006 agreement.

NOW, THEREFORE, the parties hereto agree for themselves, their successors, and assigns as follows:

That the March 1, 2006 agreement be extended for a period of one year from the date of the execution of this extension under the same terms and conditions as set forth in the March, 1, 2006 agreement.




