Public Hearing – Socioeconomics and Environmental Justice Impacts of the Proposed Wastewater Interceptors and Treatment Facility Improvements along Killian Creek and Forney Creek in Eastern Lincoln County: Mike Wolfe, with WK Dickson, stated that they are here to receive comments to the Environmental Justice portion of the environmental review. Environmental Justice takes a look at the populations looking for poverty areas, minority areas, and low income areas and how they are affected by the project. The treatment plant is located in an area where less than 10% of the residents are low-income. Minorities are less than 20% in the service area. No impacts were found related to race or poverty.
