The Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in this county and hereby publishes this Request for Proposals. The JCPC anticipates funds from the NC Department of Public Safety, Division of Adulut Services and Juvenile Justice, Community Programs section in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the state fiscal year 2014-15 beginning on, or after, July 1, 2014. The use of these funds in this county requires a local match in the amount specified above.

**The JCPC will consider proposals for the following needed programs:**

Parent and Family Skill Building	Teen Court	
Interpersonal Skills	Home Based Family Services	Sex Offender Treatment Services
Mediation	Assessments	Substance Abuse Services
Restitution/Community Service	Counseling	Crisis Counseling Services

**Proposed program services should target the following risk factors for delinquency or repeat delinquency:**

## Alcohol/Substance Abuse; Peer Relationships; Serious School Problems; Recidivism Prevention

Programs should address the following concerns as reported in the Needs Assessments for adjudicated youth:

Peer Domain:	Rejection by positive peers significantly increased, as has some association with delinquent peers, and regular association decreased slightly. Lack of positive peer interaction continues as a problem.
Individual Domain:	Lincoln County has lower than State average for further mental health assessment, increased need for mental health assessment, substance abuse assessment and treatment.
Family Domain:	Family substance abuse rate decreased, but is slightly higher than the State, conflict in home is higher than State rate, inadequate supervision skills continues to be a problem, although slight decrease from last year,
School Domain:	Decrease in minor and moderate behavior problems, but higher than State rate for minor. Marked increase in serious school behaviors in Lincoln County, but lower overall than State rate.

**Applicants are being sought that are able to address items below:**

1. Program services compatible with research that are shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services detect gang participation and divert individual

Local public agencies, 501(c)(3) non-profit corporations and local housing authorities are invited to submit applications to provide services addressing the above elements.
