4. No smoking signage to be placed in accordance to fire official if required (every 75 feet throughout the trail)
5. Type, size, quantity and location of Fire Protection Equipment
6. Names of two personnel and phone numbers for contact during emergencies
7. IF TORCHES USED ON TRAIL someone must be with each torch at all times.
8. Fire extinguishers (min. 5 lb. ABC) to be placed every 150 feet throughout the trail.
9. Each night must have a meeting with all staff to go over safety rules and what to do during an emergency.
10. A way to call for help during an emergency throughout the trail (each staff member - cell phone/radios)
11. Fill out Special Event Application with the County
