9. N.C. State Fire Sprinkler Contractor License's Number
10. When was water flow test done (date & time), by whom, distance to test hydrant, were county water system pumps on
11. Occupancy hazards, storage and commodities (location of these items) Are all areas of building rated the same occupancy
12. Building heights, width, length
13. Plans should be prepared in accordance to NFPA 13 (A-8-1) (1999) (drawings to be on 1/8" scale)
14. Will there be rack storage (if so will need drawings for racks include height of rack, storage on racks, type of racks)
15. Site plan to be provided (show water lines & size, back flow preventer, hydrants, F.D.C. and check valve for F.D.C.)
16. Will a fire pump be used (if so will need information of pump and placement)

This application shall be considered valid as long as the above criteria, codes and local ordinances are met.

Conditions, surroundings and arrangements to be in accordance with the NC State Building Code - Fire Prevention Code. Complete plans and construction details must be filed on all major projects when requested by the Fire Marshal's Office.
