6. Aboveground or belowground storage
7. Proof of public liability insurance or bond not less than \$ 1,000,000.00
7. Type, size, quantity, and locations of Fire Protection Equipment
9. State what NFPA Codes are to be met
10. State what NC State Building Code – Fire Prevention Codes are to be met
11. No smoking and NFPA 704M signage to be placed in accordance to fire official
12. Firm or person transporting explosives and/or blasting agents into Lincoln County shall contact Fire Marshal prior to bringing materials into county
13. Owner of property utilized for storage
14. Primary and secondary emergency contact personnel and phone numbers for each

**This application shall be considered valid as long as the above criteria, codes and local ordinances are met.**

Conditions, surroundings and arrangements to be in accordance with the NC State Building Code - Fire Prevention Code. Complete plans and construction details must be filed on all major projects when requested by the Fire Marshal's Office.
