Alternate Bid #1 – Concrete Walk: This Bid consists of the following: Furnish and install all work required for additional concrete walk as indicated on drawings. The walk is approximately 166 linear feet and 5'-0" wide. Work shall include all necessary grading, backfill and grassing as required.

Alternate Bid #2 – Accessible Parking: This Bid consists of the following: Furnish and install all work required for new accessible parking spaces as indicated on drawings. Provide (2) new paved accessible parking spaces. Work shall include grading, concrete curbing, concrete walk, accessibility signage, asphalt paving, pavement striping, backfill and grassing as required.

Alternate Bid #3 – Asphalt Paving: This Bid consists of the following: Furnish and install all work required to repave and restripe two existing asphalt parking areas and the existing drive as indicated on the drawings. Work shall include removing and/or repairing as required existing damaged areas of paving prior to installing new pavement. Work shall include any necessary grading, backfill and grassing as required.

Alternate Bid #4 – Manual Roller Shades: This Bid consists of the following: Furnish and install roller shades within the interior wall opening of each window as indicated on drawings.

Alternate Bid #5a – Solid Surface Counter Tops: This Bid consists of the following: Furnish and install all work required to provide solid surface counter tops and splashes on all counter tops including Café, Kitchen, Games Room and Reception Desk. Plastic laminate countertops shall be provided within Base Bid.

Alternate Bid #5b – Solid Quartz Surface Countertops: This Bid consists of the following: Furnish and install all work required to provide solid quartz surface counter tops and splashes in Café, Kitchen, Games Room and Reception Desk. Plastic laminate countertops shall be provided within Base Bid.

Alternate Bid #6 – Walkway Canopy: This Bid consists of the following: Furnish and install all work required to provide an aluminum walkway canopy with internal drainage.
